

How to prepare an exhibit for fair judging and display

- Fill out an entry card (both sides and do not tear apart)
 - Name, club, exhibitor number, class name and number
- Fill out a sticky label (foods and livestock do not need this)
 - This is in-case exhibit is lost /found
 - Mailing address label can be used with exhibitor name, class name and number.
 - Template for these labels can be found on our website.

- Attach entry card with string, rubber band or safety pins. For photos the entry card should be taped to the back of the board with one piece of tape over the entry card hole.
- Photos must have a release strip taped to the front of the board below the photo. Tape both ends and do not glue.
- If the exhibit is to have a description of how you made the item it should be permanently attached also with string, rubber band or safety pin.
- Several projects need additional information such as plans, directions, and cost per wear. See your division for more specific information.
- All exhibits must be clean and free of stains. Display your exhibit with pride, you have put a lot of work into it.

Please make sure that both sides are filled out and this is attached to fair exhibit. Side with hole will be left with exhibit and other side will come to office.
