If reenrollment is not completed by this deadline, youth will become ineligible for the current year to receive exhibitor premiums or participate in premium auctions, hold a leadership position at the county or district level, and more! KYLF will feature leadership workshops, Youth Council elections, and opportunities to learn and have fun. Registration will open in August. Registration deadline is **October 15, 2025 by 11:59 PM**. The Kansas State Fair is one of the largest events in Kansas. It is September 5-14 in Hutchinson. This is the capstone event for many 4-Hers in their project work, but the Fair offers something for everyone. For information about the 2025 Kansas State Fair, please visit www.kansasstatefair.com/.

Important Due Date—September 30

September 30 is the last day of the 4-H year. This time of year is also a beneficial time to reflect on your year in 4-H: did you meet your goals, what have you learned, how can you improve for next year, have you grown as a young person through your 4-H work? The 4-H record book, especially Permanent Record and 4-H story, is a perfect place to journal this reflection. **LEADERS – September 30** is the date that completed 4-H Record Books, Achievement Pin applications (submitted to you by member), Club Seal Summary reports, Club Goal Summary reports, and other important local forms are all due to the Extension office. Youth Council and National Conference Applications

The Youth Council application and National Conference application are again combined this year. Applicants will indicate if they are applying for one or both opportunities.

This year's KYLF delegation will elect representatives from the four extension program regions (NE, NW, SE, SW) for one-year terms on council. Up to six National Conference delegates will be selected through an interview process at KYLF and they serve a two-year term on council.

The deadline to apply is October 1, 2025, by 11:59 PM.

Club Elections

The following are suggested guidelines for conducting the 2025-26 club election of officers:

• Nominate and vote for the member who would carry out the responsibilities of the office well.

Election of officers should not be a popularity contest.

- A nominating committee, made up of 4-H members & parents, should develop a slate of candidates, preferably two or more candidates per office.
- Vote on each office individually. It takes extra time, but allows important learning time for members.
- Club members should be allowed the opportunity to nominate members from the floor for offices.
- A club needs to have a motion, a second and approval to close the nominations for each office.
- A nomination does not need to be a motion. It can simply be, "I nominate Sally".
- Voting should be done by ballot. Ballots should be counted by two to three members who are not running for office and preferably not by members who made the nominations or by parents.
- Each member should have one vote per office.
- In cases where the club may have more than one person in office, each member should vote for corresponding candidates.

4hOnline

With another year of experience in 4hOnline, we hope that your interaction with the site went well! With that being said, now is a great time to review your 4hOnline account to make sure your data is accurate. This can mean your contact information, but years in each project and other data needs to be corrected prior to the end of the current 4-H year. September is the month for staff to do reviews, reports and maintenance; so please let us know of issues or corrections as soon as possible.

Screened and registered 4-H adult volunteers who do not have an active enrollment in 4hOnline will need to get this done as soon as possible! You could be in jeopardy of losing your status as a registered Kansas 4-H Volunteer. Members, as a reminder, club and project enrollment will not automatically propagate in your accounts, so please watch carefully come enrollment time. Stay tuned for more information, but please note that the enrollment process for the **2025-2026** year will not begin until **October 1**.

Setting S.M.A.R.T. Goals

As you begin to think ahead about the new 4-H year, you may have things you want to improve, change, or accomplish as the year progresses. A great way to quantify these thoughts would be setting goals. All in all, these tactics will help you set goals that will increase your likelihood of successfully achieving your goals.

Setting goals is an important aspect of success, and how we can measure success. It can help guide focus and help trigger new behaviors. Ultimately, they help manage your focus and success.

Goals need to be S.M.A.R.T. which stands for:

- Specific This is where you want you should be thinking about what you want to accomplish. This is where you would have to ask yourself the "W" questions; who is involved, what are you accomplishing, where is this, when will this be done, and why are you doing this?
- Measurable What are you measuring to determine if you have met the goal? This will help make more quantifiable and provides a way to determine the progress of your goal.
- Achievable This will focus on the importance of the goal. Additionally, you should think about how to accomplish the goal and if you have the skills and tools to accomplish the goal.
- Relevant This should be focused around what makes sense for the broader picture at hand.
- Time-bound A target finish date should be set for your S.M.A.R.T. goal. Additionally, you should have other check-in dates as well to ensure that you are on track to achieve your goal.

Here are two examples of S.M.A.R.T. goals that I pulled from 4-h.org:

- 1. Learn how to use my DSLR camera by completing the photography 4-H project and enrolling in the Clover County Library's basic photography class this June.
- 2. Apply to be a 4-H Camp Counselor for this summer and complete all required training by June 1.

I encourage you and your family to sit down and reflect on the last year. Next, I encourage you to think about the future year and develop S.M.A.R.T. goals to track your success as a 4-H family. These can also be included in your Record Books!



Tell Your Story: 4-H Record Books

4-H Record books can be what we love to hate. This is especially true if they are just getting started. It is easy to say that they should have been started back in January, but that isn't helpful at all right now and only spoken with an ironic smile. The purpose of 4-H projects is to grow in knowledge through hands-on applications, "Learn by Doing." Record books are how growth within a project is documented and shown. Reflecting on your year of learning is a large part of 4-H; it is a large part of life. Learning how to accurately keep records can help prepare youth for future scholarship and job applications, money management, and goal evaluation.

So where do you get started? There are two formats that can be used for 4-H record books. The first one, the preferred one, is ZBooks. This program has been purchased through the Kansas State 4-H Program and funded with 4-H yearly fees. This is accessed online on the ZSuites website, https://www.kansas4-h.org/resources/awards-and-recognition/ZBooks.html. This platform requires the same login as 4HOnline. If you don't remember the password, simply click on the "Forgot Password" and reset it. There will be drop-down menus to assist with creating and completing the record book.

The second option is to download PDF pages which are located on the Meadowlark 4-Her Resource page. These can then be handwritten for the Junior 7-9 Age Group or completed with Adobe on a computer and printed. Both options are available and can be competitively judged.

So, what constitutes an official record book? According to the Guide to Kansas 4-H Recognition, a complete record book is the personal page, general 4-H story, permanent record, and at least one competed project record. You are encouraged to complete a project record for each enrolled project. However, please don't hate 4-H and life because of record books. It is better to focus on completing a few amazing project records than to hurriedly patch together many. Participants will have the opportunity to dive into interactive content they can use to engage their youth members, connect with state and local extension staff to learn about new and exciting 4-H happenings, and engage with the Kansas Association of 4-H Volunteers as a support system for volunteering efforts throughout the year. Registration for this event will open in **September.**

Kansas 4-H offers a wide variety of involvement opportunities for adult volunteers, from a one-time event or program to a multi-year experience as a club or project leader. There are many roles for volunteers. Check with your local club and/or Extension Office for more information.

Write thank you notes!

As District 4-H Agent, Heather Roenne, shared recently in the news, "A big part of 4-H is being grateful for the help, support, and awards that were received. A handwritten thank you note can brighten someone's day and let them know that they are appreciated."

The 2025 Donor Book is published on the Jefferson County 4-H website home page. Exhibitors may refer to this book during the thank you writing process to ensure donors receive proper recognition. A thank you note might just be the encouragement needed to continue supporting 4-H programming in Jefferson County. Thank you notes can also make a world of difference for club leaders, project leaders, or anyone who assisted with project preparation throughout the year.

Our 4-H staff has a few notes of appreciation to share. To the volunteers, your commitment to the vitality of our program elevates the success of our events year after year. To the donors and auction buyers, you are ensuring a bright future for 4-H youth. To the 4-H members, you are the heart of our program!

Prepare record books

Each club sets a deadline, typically in September, for project record books to be submitted. This deadline allows time for books to be transferred to the designated judging county. Resources for building project records can be found at meadow-lark.ksu.edu/4-h/project_records.html.

We have set **October 13** as record book judging day at the Fairgrounds and are looking for volunteers to assist in this process. More information to follow.

Anticipate premium checks

As fair exhibit results are finalized, office staff are in the process of preparing premium checks to be distributed via club leaders. We plan to mail Livestock Premium Sale checks directly — and of note with sale checks: a nominal fee is deducted to cover buyer plaques, accounting, and other sale costs.

Kansas State Fair

The 4-H office needs all pre-entered state fair exhibits dropped off by **noon on Wednesday**, **September 3** in order to have those projects transported to Hutchinson. We advise those exhibitors sending projects on to closely read state fair rules to understand what information should be enclosed with each project — there may be variations from county requirements.

With those projects, participants of the state fair are eligible for general admission tickets to the Kansas State Fair. Check with the office about receiving a pair.

Fair Premium Checks

Premium checks will be sent to the club treasurers in **September**. The club treasurer will then hand out premium money to exhibitors at your club meetings.

Livestock premium checks, decorated cakes, cookie jars and bread basket checks will be mailed directly to members in September. You will see a small deduction to cover banners and meals for buyers, accounting fees and other cost associated with sale. 4-Hers please remember to send your buyers a thank you!

If you see a green ribbon on your statement, that is for any exhibits that were not pre-entered or those exhibits taken home before check-out time. You will not be paid for these ribbons.

State Fair Entries

All exhibits going to the state fair need to be at the Extension Office before noon on Wednesday, September 3. We strongly encourage you to bring in your non-perishables state exhibits before September 1. You will be able to pick up your state fair entries anytime on September 18 or thereafter.

4-H Record Books

The last phase of the 4-H year is the record book process. All 4-Hers will need to complete their record books. All forms can be found on our website https://www.meadowlark.k-state.edu/4-h/ project records.html It's time to record what happened during the year, what you've learned, what brought you success and what you can improve upon.

There is a general and livestock record. You only need to fill out <u>one form for each project</u> you are enrolled in and not each exhibit you took to the fair. We ask that you turn in only your 2024-2025 records to your club leader in a <u>1" 3 ring binder</u>. Make sure you have a cover page on the binder with your name and club. If you have questions or need help with your records, please contact Deb, she will be happy to help you.

All record books are to go to your club leaders and not dropped off at the Extension office. Each club has set due dates for your record book to be turned into your club leader. Make sure to also turn in your Achievement Pin application and Event Scholarship Application which can be found on our website.

Record Book Judging

We will be judging Jefferson County Record Books on October 13 from 9:00 AM to ??? at our office. All clubs are required to provide at least 2 adult volunteers, giving 8 hours of judging time. The more volunteers, adult or older 4-Hers that we have, the quicker judging will go. If you plan to attend later in the day, a phone call to the office to check on the status of the workload is suggested before you come.

National 4-H Week

Mark your calendars for **October 5-11**, as it is National 4-H Week. I am requesting that all 4-H members wear a 4-H shirt to school **Wednesday**, **October 8**.
